

CABIN: RENTAL FEES & DEPOSITS

Residents of Tam Valley: \$35/hour

Non-Residents: \$45/hour

Tam Valley Non-Profits: \$35/hour

Public Agencies: \$30/hour

Commercial: (any event charging admission-profit or non-profit) \$60/hour

2 hour minimum

Maximum Capacity: 30 people in/outside of the cabin

Cleaning Service fee: \$150

Parking: Availability for 20 Cars

Jumpees: Permitted outside

Amplified music: Until 8:00pm

Deposit - \$150 Required in addition to the rental fee, which is returned if TCSD staff determines that all conditions of TCSD's Rental Agreement have been met. The Renter's responsibility shall not be limited to the amount of the deposit. In the event of a violation of the Rental Agreement, the deposit may be retained to recover the administrative cost of recovering damages from the Renter, which shall be in addition to the deposit amount.

No pony parties or laser tag are permitted.

Attendant Fee: \$30/hour required for *all* events, **NO EXCEPTIONS.** Any events over 8 hours will pay \$40/hr for the attendant.

PA/Speaker sound systems are not available through this rental.

Doors must be closed when amplified music is playing. Teen events require the submittal of a security plan prior to booking the center.

Tam Valley Residents: \$1200 per 2 - 8 hr days

Non-Residents: \$1600 per 2 - 8 hr days

Tam Valley Non-Profits and Public Agencies: \$1400 per 2 - 8 hr days

Commercial (any event charging admission-profit or non-profit) \$1900 per 2 - 8 hr days

Attendant Fee: \$30/hour required for all events, NO EXCEPTIONS.
